#### CONCEPT NOTE

This session will explore equity in healthcare access in ASEAN Region against the current and future trade in health services architecture, increased choices for patients/ consumers and ASEAN initiatives such as MRAs of health professionals. It will also discuss to what extent liberalization of health services, both under and outside the trade agreements, can help improve ASEAN people's accessibility to health care, and what need to be done in order to take the benefit of trade in services to improve health and access to health care among people the ASEAN region.

Issues under this session may include:

(1) Future medical tourism and access to health services in ASEAN

(2) Will ASEAN trade improve access to health services towards universal health coverage? (e.g. the use of Digital health / e-health to improve accessibility)

(3) Future trade in health services in the 4<sup>th</sup> industrial revolution era (e.g. the niche areas, the future needs, the use of big data to predict future needs, the precautionary points. ...)

(4) WHO Global Code of Practice on the International Recruitment of Health Personnel: A challenge or opportunity for ASEAN?

(5) Improving equitable access to healthcare in ASEAN: a case study of health insurance for marginalized group of population

Matthias Helble is an economist in the Economic Research and Regional Cooperation Department of the Asian Development Bank (ADB) in Manila. Previously, he was a Senior Research Fellow and Co-Chair of the Research Department of the Asian Development Bank Institute (ADBI) in Tokyo. His research interests include international trade, health and economic development. His research has been published in numerous scientific journals as well as in flagship reports of international

organizations. His publication record also includes eight books, including with Oxford University Press. His book "Win-Win: How International Trade Can Help Meet the SDGs" was the most downloaded ADBI book in 2017. His columns and policy work have been cited by prominent international media such as the AFP, AP, and The Straits Times.

Matthias began his professional career at the World Bank in Washington, DC, before joining the World Health Organization in Geneva, Switzerland. He then worked as an economist for the World Trade Organization as well as the United Nations before joining ADB. He holds degrees in economics from the University of Tübingen, the University of Wisconsin-Madison, and the Graduate Institute of International and Development Studies in Geneva. During his doctoral studies he was a research fellow at Yale University.

Mr. Tan Tai Hiong is currently the Assistant Director and Head of the Services and Investment Division of the ASEAN Secretariat. He has joined the ASEAN Secretariat since 2001 and has been working on the development and implementation of ASEAN policies/initiatives in the area of trade in services and subsequently also in the area of

investment, as well as on ASEAN's Free Trade Area (FTA) negotiations with its Dialogue Partners. In parallel to this, Mr. Tan has also worked on coordination and facilitation of overall trade and economic policies among ASEAN member countries as well as between ASEAN and its dialogue partners, which are coordinated through Senior Economic Officials Meeting (SEOM) and ASEAN Economic Ministers' Meeting (AEM).

Prior to joining the ASEAN Secretariat, Mr. Tan Tai Hiong worked for an international management consulting firm and then for holding company of one major business group in Indonesia. Mr. Tan worked on organisational and financial restructuring projects for various corporations during those positions, including consumer products, banking, distribution, and media corporations.

Mr. Tan obtained his Master of Arts (MA) in International Economics from Fordham University, in New York, and his Bachelor Degree in Economics and Development Studies from University of Indonesia.
