Kuala Lumpur Declaration on ASEAN 2025: Forging Ahead Together 22 November 2015, Kuala Lumpur, Malaysia

ASEAN countries have committed themselves to the implementation of the ASEAN Community Vision 2025 (ASEAN Vision 2025) and the United Nations 2030 Agenda for Sustainable Development (2030 Agenda).

The ASEAN Vision 2025 underscores the importance of "an integrated, peaceful and stable community with shared prosperity" with respect for the environment and planetary boundaries while the core principle of the UN 2030 Agenda is the need for development and well-being for all. These two initiatives highlight the need of strong partnerships and the participation of all stakeholders to promote economic growth, protect environment and natural resources and promote peace to ensure all human beings can enjoy prosperous and fulfilling lives in dignity and equality and in a healthy environment.

They also underlined the complementarity of these two agendas in their efforts to uplift the standards of living of the region's peoples. The "Complementarities Initiative" became one of the high priority activities of ASEAN over the past four years.

Seeking to improve health and increase income is common goals of trade and health policies. This is because the growth from increased trade will be shared and will improve people's lives. But the question is how to formulate trade policy to achieve economic growth and benefit health and as to what extent the "Complementarities Initiative" creates enabling conditions to formulate trade policy that achieves economic growth and benefits health

This Session aims to discuss on the complementarities between ASEAN Vision 2025 and SDGs towards common ground of trade and health in ASEAN Region. The session will also illustrate the case studies of best practice of] trade and health policy [in]coherence in ASEAN Region.

# Lead speaker Dr Nima Asgari

Director, Asia Pacific Observatory on Health Systems and Policies



Dr Nima Asgari trained in public health medicine in London and has been working in the field at low, middle and high income countries since 1996. He has been with WHO from 2006 and has previously worked at WHO HQ in Geneva as well as China, Cambodia and Thailand country offices. Nima became the director of the Asia Pacific Observatory on Health Systems and Policies (APO) in October 2016. His focus

being on expanding membership of APO, increasing the range and number of APO publications and most importantly increasing the capacity on health system research in the region and shifting the evidence to policy. Prior to joining APO, he coordinated WHO activities across key Thai public health agencies and international partners for non-communicable diseases, health related consequences of trade, health in all policies, and transformative health education. While in Cambodia, Dr. Asgari focused on strengthening critical gaps of the health system to be able to respond to emerging diseases and comply with International Health Regulations. His persistent collaboration led to the development of a national Infection prevention and control programme, the first network of public sector hospital diagnostic microbiology labs, and setting up a modified Field Epidemiology Training Program (FETP) in Cambodia. Before joining WHO, Dr Asgari worked in UK for the Health Protection Agency (HPA) at local and national level as well as the National Institute for Health and Care Excellence (NICE), where he focused physician's understanding of the grading system for clinical guidelines. Dr. Nima Asgari received his medical degree as well as Bachelor's degree in Parasitology from University of Edinburgh, Scotland. He has a Master's degree in Public Health from London School of Hygiene and Tropical Medicine and is a fellow of the Faculty of Public Health in England.

Director Mahidol University Global Health



Dr. Wiwat Rojanapithayakorn is currently the Director of Mahidol University Global Health Program. He is also the Executive Director of AUN-Health Promotion Network. He used to work for the World Health Organization in the capacities of Medical Officer of WHO Mongolia (2002-2004), Senior Advisor and HIV/AIDS Team

Leader of WHO China (2005-2008) and the Representative of the World Health Organization in Mongolia (2009-2012). Before joining WHO he was the Team Leader of UNAIDS Southeast Asia and Pacific Inter-Country Team based in Bangkok (for 2.5 years). He had worked in Ministry of Public Health of Thailand for 23 years in different capacities such as director of 2 community hospitals, the first director of national AIDS programme, the director of a regional office of communicable disease control, and the first director of the national dengue control office. He has authored or coauthored more than 110 publications in English and Thai; and was editor or chief editor of 15 public health journals. In 2010, he received Prince Mahidol Award in Public Health from his efforts in the development and scaling-up the 100% 100% Condom Use Programme which prevented millions of HIV infection in Thailand and 7 other Asian countries.
